



# **Oman Visa**

# Important information about the visa for Oman

A visa is mandatory for a trip to Oman. It is no longer possible to apply for a visa on arrival at the airport since March 2018. The electronic visa for Oman can be applied for online and will be sent by e-mail after it is granted.

### For whom

European travellers must apply for a visa before travelling to Oman. The Visa on Arrival, which could previously be applied for after arrival at the airport, is no longer offered. Instead, travellers can simply apply for their visa online. The electronic visa is suitable for tourists who want to stay in the country for a maximum of 30 consecutive days. Most British and Irish holidaymakers meet the requirements of the e-visa and can therefore submit their application online.

### Requirements

To apply for an Oman visa, the following requirements apply:

- You are travelling to Oman on holiday
- You are travelling with a standard passport
- Your passport is valid for at least 6 more months on the date of arrival in Oman and contains at least one blank page
- You have arranged accommodation and booked a return or transit ticket before arriving in Oman

People who are travelling to Oman for business, to study or to perform (volunteer) work and people who do not have a regular passport but an identity card, an emergency passport or a residence permit, do not meet the requirements for the Oman visa. Is your passport valid for less than 6 months upon arrival in Oman? First apply for a new passport and only then for your Oman visa.

#### Single entry visa

A single entry visa allows you to enter Oman once. It is not possible to leave the country prematurely and return at a later date with this type of visa. The single entry Oman visa comes in two variants: a visa for a stay of up to 10 days and a visa for a stay of up to 30 days. The 10-day visa costs £49.95 per person, the 30-day visa £89.95 per person.

### Multiple entry visa

Travellers who plan to travel to Oman several times are advised to apply for a multiple-entry visa. This visa allows you to arrive in Oman an unlimited number of times within the validity period of one year. Each individual stay in the country may not exceed 30 days. The cost of this Oman visa is £159.95 per person.

### How to apply

The visa for Oman can be easily applied for online. It only takes a few minutes to fill in the application form. Enter your contact and passport details and some information about your trip in the application form. After filling in the form, check the completed data and pay the fees. The cost of the visa can be paid safely and quickly with Visa, MasterCard, American Express and PayPal. Finally, you upload a scan or photo of your passport and a passport photograph. Once these documents have been approved, the application will be processed.

Applications are processed after an average of 7 days. You will then receive a confirmation by email and text message, and all that is left is to print the visa. Always check that the details on the visa correspond with your passport details. An error in the passport information can lead to the visa not to being linked to your passport and thus being invalid. An issued visa is therefore no guarantee of actual entry into the country. For example, travellers who have an Israel stamp in their passport may be denied entry.

### **Urgent application**

Travellers who are journeying to Oman at short notice and do not yet have a visa are advised to submit an urgent application. To do so, check the option "urgent delivery" on the application form. A surcharge of £17.50 is charged for urgent applications. Urgent applications for an Oman visa are given priority and are processed in 4 days on average. As the immigration service carries out random background checks, the processing of an urgent application may take longer and no guarantee can be given as to the processing time.
