



## Sri Lanka visa

Important information about the visa for Sri Lanka

All travellers to Sri Lanka are required to apply for a visa (ETA). The information below applies to the business visa, tourist visa and the transfer visa.

Validity	30 days, can be extended (48 hours for transfers)
Normal delivery time	Within 72 hours
Urgent delivery	Average 23 minutes

#### For whom

The online visa, also called ETA or e-visa Sri Lanka, is suitable for tourists and business travellers. To be eligible for this visa, a number of requirements must be met and the maximum validity period cannot be exceeded. Read in this document which requirements and deadlines you need to take into account and how to apply for a visa for Sri Lanka.

### Requirements

Applying and using a Sri Lanka visa is only possible if you meet the following requirements:

- Your passport is valid for at least six more months after arrival in Sri Lanka
- You have printed your visa and are carrying it with you to Sri Lanka
- You are able to present a ticket for your return flight on arrival
- You can prove that you possess sufficient financial means to pay for your stay
- You will not be employed by an organisation based in Sri Lanka
- You will not perform paid or unpaid voluntary work in Sri Lanka
- You will not take part in political or journalistic gatherings

Take note: as mentioned above, it is necessary to already have a ticket for your onward or return flight upon arrival in Sri Lanka. However, it is not necessary to have already booked a ticket for the outward and/or return flight in order to apply for the Sri Lankan visa. You can also apply for a visa before booking the flight tickets.

### **Validity**

By default, the Sri Lanka visa is valid for 30 days. Do you want to stay in Sri Lanka longer than 30 days? Apply for an extension after arrival. You can do this at the Immigration Services Centre in Colombo. After extension, you can stay in Sri Lanka for an additional 60 days (90 days in total).

#### **Validity passport**

Take note: the Sri Lanka visa is linked to a specific passport. If you acquire a new passport after the visa has been granted, the visa cannot be linked to it. A new application must then be submitted (and paid for) in order to travel to Sri Lanka.

### How to apply

Applying for a Sri Lanka visa is easy. Go to website e-Visa.co.uk and click on 'Sri Lanka'. Fill in the arrival date and your e-mail address and click on 'Apply now'. You will now see the application form on your screen; fill this in and click on 'Apply for Visa'. After having double-checked all filled in data, you make the payment, after which the application will be processed immediately. The Sri Lanka visa is usually issued within 72 hours. You will receive a confirmation by e-mail, with a link to download the visa. Print it and take it with you to Sri Lanka.

#### **Urgent applications**

Are you flying to Sri Lanka within 72 hours and haven't had time to arrange your visa? Submit an urgent application immediately. Emergency applications for the Sri Lanka visa are usually granted within 23 minutes. A surcharge of £17.50 per traveller applies. Keep in mind that no guarantees can be given regarding delivery times of visas, even with urgent applications. Sri Lanka's immigration service reserves the right to randomly select applications for a more extensive screening, which can result in delays.
